School Fees, Levies and Resources 2019

School Fees and Levies are charged in accordance with the "Recommended minimum fees and levies" as set by Brisbane Catholic Education.

It is understood that parents comply with the spirit of the School Mission Statement and agree to pay such fees and mandatory levies as set by the local authority.

School Fees & Accounts (Prep to Year 6)

Fees are issued monthly for 10 months of the year (February to November). The school will accept Cash, Eftpos, Direct Debit and BPay and BPoint. Please see the School Finance Secretary for paperwork, if you choose to pay by Direct Debit deductions.

Curriculum Levy (all students)

For your convenience a Curriculum Levy will be charged to your school fees to cover the cost of text books and consumables for the year and *is in lieu* of parents purchasing a bookpack. As a cost saving measure we have bulk ordered the consumables (glue, whiteboard markers, exercise books, etc) for each class. This annual levy covers the cost of art and craft materials, science materials, photocopying and any other classroom general resources. It also assists in maintaining and upgrading the range of technology available at our school. These resources include notebooks, surface pros and iPad systems which cater to the entire school in a one to one technology capacity. The levy also includes your login and access to Soundwaves, Mathletics and Reading Eggs both at home and at school.

Per Child per year \$350.00

Student Activity Levy (all students)

The cost relating to excursions will be billed to each family as an annual levy on a per child basis in the first month's school fee bill. As excursions are planned as part of the curriculum, all children are expected to participate. This levy includes swimming, life education, all arts council performances, dance cart and individual class excursions. This levy is designed to help with budgeting for families. There will be no additional fees to families for school excursions.

Capital Maintenance Levy (all students)

The Capital Maintenance Levy is used to repay loans, refurbish and maintain classrooms and other school buildings.
